LICENCE TERMS AND CONDITIONS

THIS IS A LEGAL AGREEMENT BETWEEN YOU ("LICENSEE") AND SPH MAGAZINES PTE LTD ("SPH MAGAZINES"). BY ACCEPTING AND USING THE LICENSED MATERIAL, YOU AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT.

1. Definition

- 1.1 "Licensed Material" means any still image, film or video footage, audio product, visual representation generated optically, electronically, digitally or by any other means, including any negatives, transparencies, film imprints, prints, original digital files or any reproductions thereof, or any other product protected by copyright, trademark, patent or other intellectual property rights, which is licensed to Licensee by SPH Magazines under the terms of this Agreement.
- 1.2 "Copyright Licence" means the agreement provided by SPH Magazines that includes among other terms, the permitted scope of use of the Licensed Material selected, any limitations on the use of the Licensed Material and the licensee fee that corresponds to the use. The Copyright Licence shall be incorporated into this Agreement and all references to the Agreement shall include the Copyright Licence.
- 1.3 "Personal Keepsake" means not for commercial purposes and only for use as a: memento, remembrance, reminder, souvenir, token, and trophy.

2. Grant of Rights

- 2.1 SPH Magazines grants to Licensee a non-exclusive, nonsub licensable and non-assignable right to use and reproduce the Licensed Material identified in the Copyright Licence.
- 2.2 If Licensee is obtaining rights on behalf of a client, it may permit the client to exercise the rights granted, subject to the client or any representative, subcontractor, agent or employee being bound by the same terms contained herein the Agreement. Notwithstanding the foregoing, Licensee and client or any representative, subcontractor, agent or employee remain jointly and/or severally liable and responsible for all uses. No ownership or copyright in shall transfer to Licensee by the grant of the license contained in this Agreement. All rights not expressly granted to the Licensee are reserved to SPH Magazines and the copyright holder.
- 2.3 Use of the Licensed Material is strictly limited to the use, medium, period of time, print run, placement, size of Licensed Material, territory and any other restrictions specified in the Copyright Licence.
- 2.4 Subject to applicability and the extent of the permission granted, Licensed Material may be cropped, provided that the integrity of the Licensed Material is not compromised, but shall not, under any circumstances, otherwise be rotated, altered, changed or tampered with, either manually or electronically, without SPH Magazines' express written permission.

3. Restrictions on Use

3.1 Licensee may not use nor permit the use of the Licensed Material beyond the terms of the License Agreement without first obtaining an additional license, including any electronic or digitised reproduction or promotional rights.

- 3.2 Licensed Material shall not be incorporated into a logo, trademark or service mark.
- 3.3 Licensee may not make the Licensed Material available in any medium in a manner intended to allow or invite persons to download or extract the Licensed Material.
- 3.4 Pornographic, defamatory, seditious or otherwise unlawful use of Licensed Material is strictly prohibited, whether directly or in context or juxtaposition with specific subject matter.

4. Indemnification

- 4.1 Licensee will take all necessary precautions to ensure that there is no unauthorised infringement or breach of this licence and in the event that Licensee becomes aware of any infringement or breach, Licensee shall notify SPH Magazines immediately.
- 4.2 Licensee agrees to defend, indemnify and hold SPH Magazines and its parent, subsidiaries and affiliates and their respective officers, directors and employees harmless from all damages, liabilities and expenses (including reasonable attorneys' fees and costs), arising out of or as a result of claims by third parties relating to Licensee's use of any Licensed Material outside the scope of this Agreement or any other breach by Licensee of this Agreement.

5. Miscellaneous

- 5.1 Any use of Licensed Material in a manner not expressly authorized by this Agreement or in breach of a term of this Agreement constitutes copyright infringement, entitling SPH Magazines to exercise all rights and remedies available to it under copyright laws around the world. Licensee shall be responsible for any damages resulting from any such copyright infringement, including any claims by a third party. In addition and without prejudice to SPH Magazines' other remedies under this Agreement, SPH Magazines reserves the right to charge and Licensee agrees to pay a fee equal to up to five (5) times SPH Magazines' standard license fee for the unauthorized use of the Licensed Material not including any costs and expenses incurred as a result of a breach of the terms and conditions contained herein.
- 5.2 This Agreement and the Copyright Licence contains all the terms of the agreement between SPH Magazines and Licensee and no term or conditions may be added or deleted unless made in writing and signed by both parties. In the event of any inconsistency between the terms contained herein or other writing sent by Licensee, the terms of this Agreement shall govern.
- 5.3 This Licensed Material is provided "as is": SPH MAGAZINES DOES NOT WARRANT OR GUARANTEE ITS ACCURACY, COMPLETENESS, MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NON-INFRINGEMENT.
- 5.4 This Agreement and the Copyright Licence shall be governed by the laws of Singapore. The Parties agree that the Contracts (Rights of Third Parties) Act Cap 53B shall not apply to this Agreement.
